

**CITY OF VIROQUA  
COUNCIL MINUTES  
MAY 11, 2010**

**1. Roll call:**

The regular meeting of the Common Council was called to order at 7:30 p.m. by Mayor Larry Fanta with Alderpersons David Tryggstad, Marc Polsean, Charles Steinhoff, Gary Krause, Weston Mack, Cyndy Hubbard and John Thompson present. Jeff Clifton and Terry Noble were absent Also present were Administrator Matt Giese, Clerk John Severson, Public Works Superintendent Steve Clark, Utility Clerk Nancy Bekkedal and Justin Running.

**2. Approval of the April 27, 2010 Regular Council Minutes**

Motion by Alderperson Noble to approve the April 27, 2010 Council minutes. Seconded by Alderperson Steinhoff. All voted aye on voice vote. Motion carries.

**3. First period for public comment**

Dave Treptow addressed the Council concerning horse droppings that are not being cleaned up. Mr. Treptow ask the council to consider an ordinance requiring owners to clean up after their horses.
