#### 1. Roll call:

### 2. Approval of the April 29, 2008 Regular Council Minutes.

# 6. Appointment to the Viroqua Housing Authority Board. Sue Walby.

Motion by Alderperson Tryggestad to appoint Sue Walby to a five year term. Seconded by Alderperson Frie. All voted aye on voice vote. Motion carries.

# 7. Denial of claim by Meredith Ames.

### 11. Payment for the concrete pad and purchase of equipment for the skatepark.

Alderperson Noble reviewed the proposed equipment for the skatepark with an estimated cost of \$41,000.00. Current donations and pledges total approximately \$36,500.00. Alderperson Frie reported that Finance was recommending that \$4,600.00 of the 2007 budgeted skatepark funds be made available for the purchase of equipment. Source of funding for the 90 ft by 72 ft pad will be determined at a later date. Motion by Alderperson Frie to pledge \$4,600.00 of 2007 skatepark funds to the purchase of the equipment. Seconded by Alderperson Noble. All voted aye on roll call vote. Motion carries.

Motion by Alderperson Hatlem to approve the bills as presented on payment reports dated May 9, 2008 and May 13, 2008 in the amounts of \$54,687.19 and \$24,845.18. Seconded by Alderperson Tryggestad. All voted aye on roll call vote. Motion carries.
