#### 1. Roll call:

#### 2. Approval of the May 13, 2008 Regular Council Minutes.

Motion by Alderperson Mack to approve the May 13, 2008 minutes. Seconded by Alderperson Krause. All voted aye on voice. Motion carries.

### 3. First period for public comment.

### 4. Ordinance revising building permit fees. First reading.

Jeff Gohlke reviewed the revised permit fees with the Council. Motion by Alderperson Krause to approve Ordinance No.08OR007 and to waive the second reading. Seconded by Alderperson Hatlem. All voted aye on voice vote. Motion carries.

### 5. Operator licenses.

### 7. Financing of Skatepark concrete pad.

# 8. Resolution authorizing a Development Agreement with Olson Brothers Enterprises, LLP and providing for the issuance of a Tax Increment Project Revenue Bond of the City of Viroqua.

Jeff Gohlke reviewed the TID agreement with the Council. The agreement authorizes a \$225,000 Project Revenue Bond bearing 4% interest per annum with 15 year term.
