# CITY OF VIROQUA COUNCIL MINUTES JUNE 9, 2009

#### 1. Roll call:

## 2. Approval of the May 26, 2009 Regular Council Minutes

# 4. Resolution Petitioning the Secretary of Transportation for Airport Improvement Aid

Jeff Gohlke presented Resolution 09RS007 "Petition for Airport Project". Listed improvements are update airport plan, hanger area development, seal coat runway and airport pavement areas, terminal area security lighting and install PAPI/REIL on runway 11/29, clear and maintain runway approaches, acquire snow removal equipment and any necessary related work. Motion by Alderperson Polsean to approve Resolution No. 09RS007. Seconded by Alderperson Tryggestad. All voted aye on voice vote. Motion carries.

# 5. Public hearing on the application by Jim Greely Signs and Awnings Inc. on behalf of Culvers Restaurant to install an electronic variable message sign at 1002 North Main Street

Mayor Fanta called the public hearing to order. Jeff Gohlke reviewed the application which is part of the overall remodeling of the restaurant. Design Review Committee had approved the non electronic signs. The Plan Commission held a public hearing on June 1, 2009 on electronic variable message sign request and unanimously recommended approval with the following conditions:

- 1. The sign can be used from 7:00 A.M. to 10:00 P.M.
- 2. Only static messages will be allowed. Text will not scroll, spin or otherwise move across the sign face. No animated graphics will be permitted, such as flags, clouds, ballons, bubbles, etc.
- 3. The LED is to be an amber color.
- 4. Letter height can range from 3 lines of 7 inch letters, up to 2 lines of 10 inch letters.
- 5. Messages shall be visible for a minimum of 5 seconds, with a one second delay between messages.
- 6. No other signs will be permitted to be attached to the main sign or its supports.
- 7. The light intensity of the signs will be regulated by a light sensing unit so that the sign will automatically dim as ambient light decreases.

Motion by Alderperson Mack to close the public hearing and to approve the conditional use permit for the electronic variable message sign as recommended by the Plan commission. Seconded by Alderperson Hatlem. On voice vote Alderpersons Tryggestad, Polsean, Steinhoff, Mack, Hatlem, Thompson and Clifton voted aye. Alderpersons Krause and Noble voted nay. Motion carries.
