#### 1. Roll call:

## 2. Approval of the June 10, 2008 Regular Council Minutes.

# 4. Ordinance regarding Airport User Fees. Second reading.

Public Works has solicited proposals for replacing the pipe. The estimated cost is less than \$25,000. Motion by Alderperson Frie to approve the replacement of the sewer pipe.
