Motion by Alderperson Frie to waive the second reading and approve Ordinance No.06OR006. Seconded by alderperson Hatlem. All voted aye on voice vote. Motion carries.

## 9. Ordinance Regarding False Alarms.

Alderperson Mack reviewed the ordinance with the council voting that the current ordinance covers false fire alarms and this ordinance would include false police alarms. Motion by Alderperson Mack to approve Ordinance No. 06OR007 and to waive the second reading. Seconded by Alderperson Tryggestad. All voted aye on voice vote. Motion carries.

## 10. Ordinance Revising Chapter 2.12 of the Viroqua Code – Special Police Department .

Alderperson Mack explained the revisions to the ordinance involved wording changes. Attorney Jenkins added that the Public Safety Committee was substituted for the police committee. ## 12. Appointment to the Viroqua Housing Authority – Carol Sloane – 5 year term.

On roll call vote seven voted aye. Alderpersons Polsean and Suhr voted nay. Motion carries.
