1. Roll call:

The regular meeting of the Common Council was called to order at 7:30 p.m. by Mayor Larry Fanta with Alderpersons David Tryggestad, Marc Polsean, John Bjerke, Gary Krause, Weston Mack, Roger Hatlem, Gail Frie, Robert Suhr and Terry Noble present. Also present were City Administrator Jeff Gohlke, Clerk John Severson, Police Chief Mark Rahr and City Attorney David Jenkins.

2. Approval of the September 12, 2006 Regular Council Meeting.

Motion by Alderperson Mack to approve the minutes of the September 12, 2006 meeting. Seconded by Alderperson Polsean. All voted aye on voice vote. Motion carries.

3. First period for public comment.

None.

4. Operator licenses.

Motion by Alderperson Mack to approve operator licenses for Kathryn M. Obrien, Geoff K. Fluegel and Stacy Jenkins. Seconded by Alderperson Tryggestad. All voted aye on voice vote. Motion carries.

5. Alcoholic Beverage license application – Driftless Café.

6. 2007 Humane Society Contract.

7. Bond anticipation note – bids for terms.
