

**CITY OF VIROQUA  
SPECIAL COUNCIL MINUTES  
April 21, 2015**

**Roll call:**

The special meeting of the Common Council was called to order at 6:30 p.m. on April 21, 2015 by Mayor Larry Fanta with Alderpersons Steve Bekkedal, Marc Polsean, Jeff Clifton, Mike Bankes, Mark Rahr, Cyndy Hubbard, John Thompson, Tom Wilson and Terry Noble present.
