CITY OF VIROQUA COUNCIL MINUTES MARCH 29, 2011

1. Roll call:

2. Approval of the March 8, 2011 Regular Council Minutes

Motion by Alderperson Mack to approve the March 8, 2011 Council minutes. Seconded by Alderperson Noble. All voted aye on voice vote. Motion carries.

3. First period for public comment

Mayor Fanta announced that Jason Franks was honored as Police Officer of the year by the Viroqua Eagles.

4. Public hearing relating to proposed Midwestern disaster revenue bond financing to benefit Vernon Economic Development Association, Inc

Mayor Fanta called the public hearing to order. Rebecca Speckhard from Quarles & Brady participated in the public hearing via speaker phone as bond counsel for the City. Matt Geise reviewed the revenue bond financing in an amount not to exceed \$1,800,000. Sue Noble, Executive Director of VEDA, Jeff Gohlke, VEDA board member and Alvin Hanson, VEDA President answered questions from the Council. No citizens were present to be heard. Mayor Fanta closed the public hearing.

6. Resolution approving a Development agreement with and Authorizing the issuance of a not to exceed \$1,800,000 Taxable Tax Increment revenue bond to Vernon Economic Development Association, Inc.

Matt Geise presented the development agreement and tax increment revenue bond for the Vernon Economic Development Association, Inc. project. Motion by Alderperson Thompson to approve Resolution No.11RS006 a Resolution Approving A Development Agreement With And Authorizing The Issuance Of A Not To Exceed \$1,800,000 Taxable Tax Increment Revenue Bond To Vernon Economic Development Association, Inc. Seconded by Alderperson Hubbard. All voted aye on roll call vote. Motion carries.

Motion by Alderperson Steinhoff to approve the shift change on a three month trial basis. Seconded by Alderperson Clifton. All voted aye on voice vote. Motion carries.

Motion by Alderperson Polsean to adjourn to closed session. Seconded by Alderperson Steinhoff. On roll call vote all voted aye. Motion carries.

13. Resolution pertaining to non-union employee compensation in relationship to proposed Wisconsin $Act\ 10$
