## 1. Roll call:

- **2. Approval of the April 29, 2014 Regular Council Minutes** Motion by Alderperson Polsean/second by Alderperson Bankes to approve the minutes of the April 29, 2014 Council meeting. Voice vote all in favor. Motion carried.
- 3. First period for public comment none
- **4. Purchase of downtown benches and waste receptacles (Public Property)** Emily Rozeske reviewed options and prices for the Council for three waste receptacles and three benches. The color recommended was green to match the new logo being launched for the City. Alderperson Wilson stated the Historic Preservation committee recommended the color black to match the light poles and the CR-96 Victor Stanley benches. Severson stated payment for these items would come from the contingency fund if approved. Motion by Alderperson Hubbard/second by Alderperson Clifton to purchase the CR-96 benches in black and the Victory Stanley waste receptacles. Voice vote eight in favor with one no heard. Alderperson Bekkedal voting no. Motion carried. The estimated cost would be \$8026 with freight from the quotes received.

Approval of Class B liquor license application Vikemyr-Wangen Properties LLC (Public Safety)** They are renovating the former bowling alley and to move forward they need to secure a Class B liquor license. The \$10,000 reserve license plus regular fees is the only one available at this time. Motion by Alderperson Thompson/second by Alderperson Hubbard to approve the Class B reserve liquor license with issuance upon payment of fees to Vikemyr-Wangen Properties LLC. Voice vote all in favor. Motion carried.
