1. Roll call:

2. Approval of the November 24, 2009 Regular Council Minutes

4. Application for "Class A" Liquor license and Class "A" Beer license

6. Southwest Sanitation offer to Purchase Industrial Park property located at 1030 N. Nelson Parkway.

The Viroqua Development Authority and the Plan Commission had reviewed the offer to purchase and both recommended approval by the Council. The price of the 2.24 acre parcel is \$22,400. Southwest Sanitation plans to construct a 7,000 sq. ft. office and shop facility. Motion by Alderperson Polsean to approve the sale of 2.24 acres located at 1030 N. Nelson Parkway for \$22,400. a. Southwest Wisconsin 25x25 Energy Independent Community Planning Grant

Jim Olson and Todd Osmond of E3 Coalition addressed the Council concerning a multi-jurisdictional 25x25 EIC Planning Grant. The grant would be use to help develop a 25x25 Energy Plan. Cities and Villages in Vernon and Crawford counties would participate in the grant and share the application cost. Viroqua's application cost would be \$700.00. Motion by Alderperson Thompson to approve the grant application and cost of \$700.00. Seconded by Alderperson Clifton. All voted aye on voice vote. Motion carries.

b. Focus on Energy Staffing Grant

E3 Coalition is applying for a Focus of Energy Staffing Grant at no cost to the City. The Grant would be used to cover project management cost for the City's EECBG grant application.
