SECTION 1: Section 17.40 of the Viroqua Municipal Code is repealed and recreated to read as follows:  
17.40 Application, Permit, Fees and Penalty.  
 (A) No person shall erect any sign without permit from the Building Inspector, which shall be issued only after written application on a form prepared by the Building Inspector if the sign complies with all of the provisions of this chapter and payment of a fee of \$42.35 per sign which costs less than \$5,000, and an additional fee of \$1 per \$1,000 cost, or part thereof, in excess of \$5,000.  
 (B) Any person who erects a sign without permit shall be required to forfeit twice the amount of the application fees.
