

ORDINANCE NO. 21OR005

An Ordinance establishing City Wards based on the 2020 census

The Common Council of the City of Viroqua ordains as follows:

Section 1: Chapter 1.08 of the Viroqua Municipal Code is repealed and recreated to read as follows:

1.08.010 Division and establishment. The City shall be divided into nine wards numbered from 1 to 9 inclusive. The boundaries and numbers of the nine wards are as follows.

1.08.020 First Ward. The First Ward shall be designated and known as all that territory embraced within the following street, avenue, or other public boundary: Commencing at the West corporate limit line of the City of Viroqua and the intersection of State Highway 56; thence East along said State Highway 56 and Broadway Street to the intersection of Western Avenue; thence North on Western Avenue to Marquette Street; thence East on Marquette Street to Chicago Avenue; thence North on Chicago Avenue about one block to the City corporate limits; thence West on such corporate limits line to the West corporate limit line of the City of Viroqua; thence South following the corporate limits, to State Highway 56.

1.08.030 Second Ward. The Second Ward shall be designated and known as all that territory embraced within the following street, avenue, or other public boundary: Commencing at the intersection of State Highway 56 and the West corporate limit line of the City of Viroqua; thence East on State Highway 56 and Broadway Street to Chicago Avenue; thence South on Chicago Avenue to Independence Street; thence East on Independence Street to Minshall Avenue; thence South on Minshall Avenue to Gillette Street; thence East on Gillette Street to Dunlap Avenue; thence South on Dunlap Avenue to Decker Street; thence West on Decker Street to Blackhawk Drive; thence West on Blackhawk Drive to Ben Lawton Drive; thence South on Ben Lawton Drive to Johnson Street; thence East on Johnson Street to Parkwood Trail; thence South on Parkwood Trail to South Street; thence East on South Street to Dairyland Drive; thence South on Dairyland Drive to Sidie Hollow Road; thence South on Sidie Hollow Road to the City of Viroqua corporate limits; thence North, and following the corporate limits, to State Highway 56.

1.08.040 Third Ward. The Third Ward shall be designated and known as all that territory embraced within the following street, avenue, or other public boundary: Commencing at the intersection of Broadway Street and Western Avenue; thence North on Western Avenue to Marquette Street; thence East on Marquette Street to Chicago Avenue; thence North on Chicago Avenue about one block to the City corporate limits; thence East along such corporate limits to Main Street; thence South on Main Street to Fairview Drive; thence East on Fairview Drive to Washington Avenue; thence South on Washington Avenue to Parkinson Street; thence West on Parkinson Street to Main Street; thence South on Main Street to Decker Street; thence West on Decker Street to Dunlap Avenue; thence North on Dunlap Avenue to Gillette Street; thence West

on Gillette Street to Minshall Avenue; thence North on Minshall Avenue to Independence Street; thence West on Independence Street to Chicago Avenue; thence North on Chicago Avenue to Broadway Street; thence West on Broadway Street to Western Avenue.

1.08.050 Fourth Ward. The Fourth Ward shall be designated and known as all that territory embraced within the following street, avenue, or other public boundary; Commencing at the intersection of Decker Street and Rock Avenue; thence East on Decker Street to Main Street; thence North on Main Street to Parkinson Street; thence East on Parkinson Street to Washington Avenue; thence North on Washington Avenue to Church Street; thence East on Church Street to East Avenue; thence South on East Avenue to Decker Street; thence East on Decker Street to Lincoln Avenue; thence South on Lincoln Avenue to Jefferson Street; thence West on Jefferson Street to Rock Avenue; thence North on Rock Avenue to Decker Street.

1.08.060 Fifth Ward. The Fifth Ward shall be designated and known as all that territory embraced within the following street, avenue, or other public boundary: Commencing at the intersection of Blackhawk Drive and Ben Lawton Drive; thence East to Decker Street; thence East on Decker Street to Rock Avenue; thence South on Rock Avenue to Oak Street; thence West on Oak Street to Garfield Avenue; thence North on Garfield Avenue to South Street; thence West on South Street to Parkwood Trail; thence North on Parkwood Trail to Johnson Street; thence West on Johnson Street to Ben Lawton Drive; thence North on Ben Lawton Drive to Blackhawk Drive.


1.08.070 Sixth Ward. The Sixth Ward shall be designated and known as all that territory embraced within the following street, avenue, or other public boundary: Commencing at the intersection of the West corporate limits of the City of Viroqua and Sidie Hollow Road; thence North on Sidie Hollow Road to the intersection with Dairyland Drive; thence North on Dairyland Drive to South Street; thence East on South Street to Garfield Avenue; thence South on Garfield Avenue to Oak Street; thence East on Oak Street to Rock Avenue; thence South on Rock Avenue to Maple Street; thence East on Maple Street to Main Street; thence South on Main Street/US Highway 14 to the South corporate limit of the City of Viroqua; thence following said corporate limit first South and then North to County Road J; thence South on County Road J to the corporate limits of the City of Viroqua; thence along the South corporate limit line of the City of Viroqua, West, to the Southwest corporate limit corner of the City of Viroqua; thence North on the West corporate limit line of the City of Viroqua to the intersection with Sidie Hollow Road.

1.08.080 Seventh Ward. The Seventh Ward shall be designated and known as all that territory embraced within the following street, avenue, or other public boundary: Commencing at the intersection of Rock Avenue and South Street; thence South on Rock Avenue to Maple Street; thence East on Maple Street to Main Street; thence South on Main Street/US Highway 14 to the corporate limits of the City of Viroqua, thence following the corporate limits in the Southeast part of the City to the Southeast corporate limit corner of the City of Viroqua; thence North on the East corporate limit line of the City of Viroqua to Mahoney Road; thence West on Mahoney Road and South Street to Rock Avenue

1.08.090 Eighth Ward. The Eighth Ward shall be designated and known as all that territory embraced within the following street, avenue, or other public boundary: Commencing at the East corporate limit line of the City of Viroqua and Mahoney Road; thence West on Mahoney Road and South Street to Rock Avenue; thence North on Rock Avenue to Jefferson Street; thence East on Jefferson Street to Lincoln Avenue; thence North on Lincoln Avenue to Decker Street; thence West on Decker Street to East Avenue; thence North on East Avenue to Parkinson Street; thence East on Parkinson Street to Railroad Avenue; thence North on Railroad Avenue to Arena Drive; thence continuing North on Railroad about one block to the City corporate limit line; thence East on such corporate limit line to the East corporate limit of the City of Viroqua; thence South following the East corporate limit of the City of Viroqua to Mahoney Road.

1.08.100 Ninth Ward. The Ninth ward shall be designated and known as all that territory in the North, Northeast and Northwest part of the City more particularly described as: North of the South lines of Section 29 and 30, Township 13 North, of Range 4 West, Vernon County, Wisconsin except those lands as designated in Ward 3, and also all that territory embraced within the following street, avenue, or other public boundary: Commencing at the intersection of the South line of Section 29, Township 13 North, of Range 4 West, Vernon County, Wisconsin with Railroad Avenue; thence South along Railroad Avenue to Parkinson Street; thence West on Parkinson Street to East Ave; thence North on East Avenue to Church Street; thence West on Church Street to Washington Avenue; thence North on Washington Avenue to Fairview Drive; thence West on Fairview Drive to Main Street; thence North on Main Street to the corporate limits of the City of Viroqua; thence following said corporate limit line to the intersection of the South line of Section 29, Township 13 North, of Range 4 West, Vernon County, Wisconsin with Railroad Avenue.

Section 2: This ordinance shall take force and be in effect upon passage and publication.
