- **2. Approval of the June 14, 2022 Regular Council minutes** Motion by Alderperson Welter/second by Alderperson Wilson to approve the minutes of the previous meeting. Voice vote all in favor. Motion carried.
- **3. Council Announcements** Alderperson Splinter tendered his resignation effective July 29, 2022 at 4:30 pm. Alderperson Birke stated the library is having a pollinator class on June 30th at 6 pm. Alderperson Wilson stated it is the 53rd anniversary of the Stonewall riots.
- **4. First period for public comment** None
- **5. Operator license approvals (Public Safety)** Motion by Alderperson Thompson/second by Alderperson Ahler to approve the operator licenses as presented pending background checks. Voice vote all in favor. Motion carried.

- 7. Review and approval of 2021 Compliance Maintenance Annual Report (CMAR) and resolution (Public Works) Sarah Grainger and Cheryl Purvis reviewed the report with Council and answered questions.
